## Type registers: some questions.

What is the "minimum functional Type Specimen Register"? There are really two parts to this question.

First, what is the minimum function a type register can perform? Second, what is the minimum set of data elements such a register must include?

The Subgroup on Type and Lectotypification Registers identified name of taxon, author, collector's name, number and date, herbarium code, country, source of information and level of verification as the minimum elements necessary to locate a type specimen. If the project goes forward in this form, the register will be a list of probable types in the world's herbaria.

Does the botanical community consider this to be a useful project? Some will feel that to be useful, a type register must do more and will see serious omissions in this proposed list of minimum elements. Mr. Burdet raised the question of including literature citations in the last issue of the newsletter. Lectotypes neotypes and their citations and reference to existing photographs have also been suggested. At what point will the requirements of the project discourage participation? The question of what is a reasonable scope for the project can be considered by each of us on light of our own experience with computerized databases. The size and complexity of the individual records is an important factor whether the final product exists as a centralized database or as distributed files.

Finally, should the holdings of herbaria who are unable to provide all of the data elements be excluded from the project? I have personally taken a conservative approach to this project, e. g., trying to define the "minimum functional type register," for two reasons. 1) To minimize the burden placed on the herbaria providing the information. 2) To attempt to define a project of reasonable scope that can reach a functional level of completion in the foreseeable future. I have written this as an individual member of TDWG rather than as a member of the subgroup, but many of my ideas come from correspondence exchanged last year. I would welcome opinions from other TDWG members. Please let me know if I can circulate your comments to the rest of the subgroup. Present members include Brummitt, Burdet, Cannon, Cullan, D'Arcy, Farr (Chairman), Morin, Pankhurst, Russell, Sutton, Thiers, Tuccinardi and Utech.


# International Register of Plant-Taxonomic Databases

## "Designs" Symposium goes ahead



Frank Bisby and Rusty Russell have been working hard to make TDWG's plans for a 1990 international symposium actually happen. The Symposium "Designs for a Global Plant Species Diversity Information System" will go ahead in autumn 1990. The exact dates (in September/October 1990) and European location will be annouced shortly. The symposium is co-sponsored by CODATA and IUBS; substantial funding has already been agreed by the Commission of the European Communities; and travel funds are under discussion with the US National Science Foundation.

The five main sessions planned cover different levels of designs suitable for a global system or network of systems to make available a catalogue of all the world's

- 1) The demand for a Global Sys-
- 2) Management, Ownership and
- 3) Taxonomic decision-making, coordination and data-entry
- 4) Data structures and logical design
- 5) System design, computers and communications

The First Circular will be mailed to everyone on the TDWG Secretariat and TDWG newsletter mailing lists. If you have ideas on contributions to the symposium, do please contact Rusty Russell or Frank Bisby in the next month or so - we would welcome more suggestions. The programme will be finalised at a meeting of the symposium planning committee on November 8th at Las Palmas, prior to the main TDWG meeting.


